Metro Atlantans woke up to mild temperatures and soggy conditions Thursday morning, with much of the area under a flood watch or warning. A majority of the metro area, as well as most of North Georgia, remained under a flood watch that has been extended through Saturday evening, according to the National Weather Service. We'll repeat the pattern today, though less rain is expected and it should break up around midday. Another round of widespread downpours is expected to arrive Saturday morning and stick around through Sunday morning.

Antisemitism bill passes Ga. House and Senate

Kemp plans to sign bill prioritized in wake of Israel-Hamas war.

The Georgia General Assembly overwhelmingly passed a bill Thursday that defines antisemitism as part of the state's hate crimes law, giving its final approval over opposition from those who say it could limit criticism of Israel.

Votes by the state Senate and House sent the bill to Gov. Brian Kemp, who said he plans to sign it into law. The Senate passed the measure 44-6, followed by a quick 129-5 vote in the House.

Lawmakers prioritized the antisemitism bill in the wake of the Israel-Hamas war that began Oct. 7, saying Jewish people need greater protections from crimes motivated by bigotry.

"Antisemitism was already at a record high before Oct. 7, and it just skyrocketed afterward, said state Rep. Esther Panitch, a Democrat from Sandy Springs and the only Jewish legislator in Georgia. "It's a recognition and a relief that we've been heard by the entire state."

Even before the Israel-Hamas war, hate groups repeatedly distributed fliers smearing Jewish people in Atlanta-area neighborhoods. Jewish residents told lawmakers about an increase

Local economy in 2023 was strong but finished mixed

6,200 jobs shed in December, but unemployment rate is 2.8%.

In a somewhat mixed coda to a surprisingly upbeat year, metro Atlanta shed jobs in December but still finished the year with a historically low unemployment rate and growth of 72,000 jobs, the state Labor Department said Thursday.

The region shed 6,200 jobs during the month, with gains in some sectors offset by losses elsewhere.

That followed robust hiring earlier in the holiday season, so the region's growth for the full year was greater than pre-pandemic, despite a chorus of economists predicting recession in the face of high interest rates and persistent inflation.

It was "a blockbuster year," said Bruce Thompson, the state labor commissioner.

The unemployment rate slid from 3.1% in November to 2.8%, within hailing distance of the record pre-pandemic low of 2.6%. The number of unemployed – out

Trump joins call to oust Fulton DA, citing bias

Former president slams Willis' remarks at historic Black church.

Donald Trump on Thursday joined a push to disqualify District Attorney Fani Willis from prosecuting Fulton County's election interference case, saying her defiant remarks at a historic Black church showed "racial animus" toward the former president and his co-defendants.

In a court filing, Trump's two top Atlanta attorneys accused Willis, who is Black, of a "glaring, flagrant, and calculated effort to foment racial bias into this case." That could unfairly prejudice a jury, they said, and violated Georgia's rules of professional conduct.

Trump's lawyers Steve Sadow and Jennifer Little weighed in a little more than two weeks after explosive allegations emerged that Willis was in a secret relationship with one of the case's special prosecutors and bene-

fiting financially from it. Willis' only public comments
